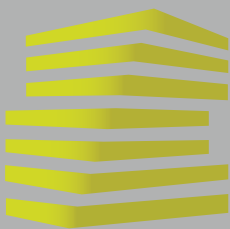

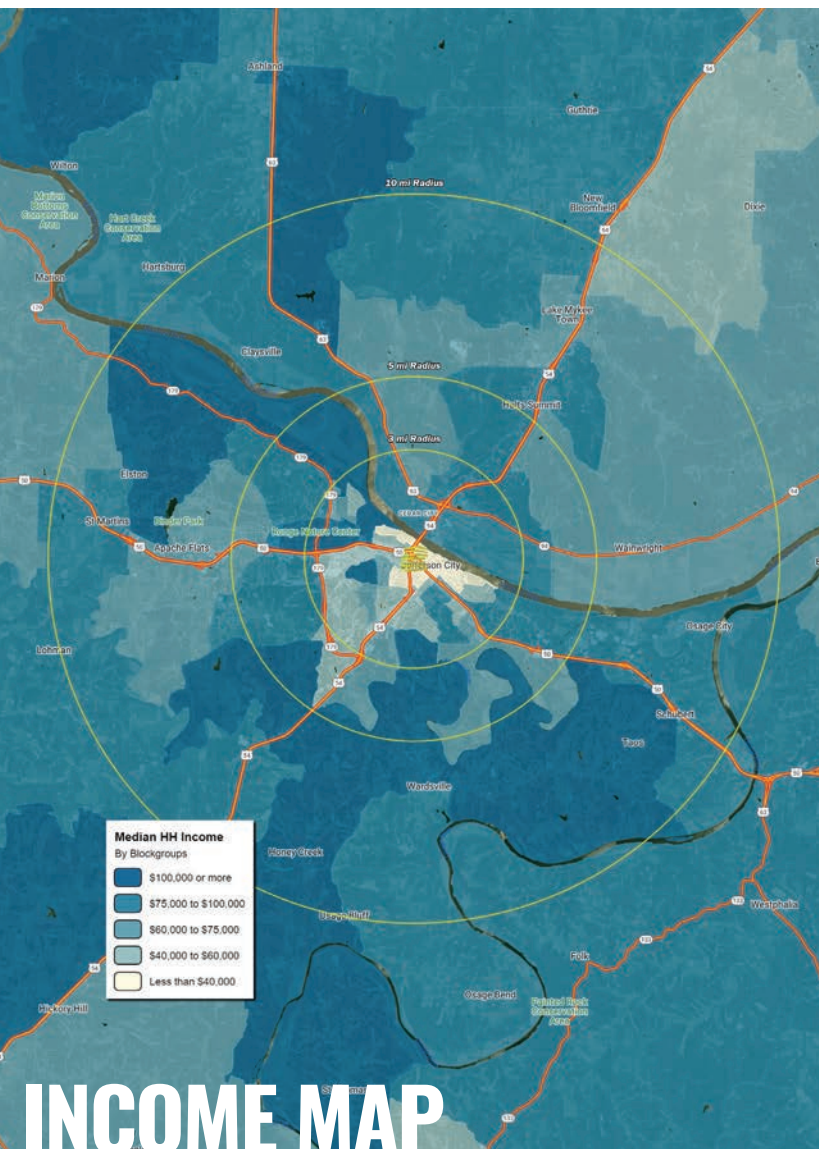

TRADE AREA OVERVIEW

Nestled in the heart of Missouri, Jefferson City stands proudly as the state capital, paying homage to President Thomas Jefferson, after whom it is named. Jefferson City is situated on the northern edge of the Ozark Plateau, gracing the southern banks of the Missouri River in Mid-Missouri.

Jefferson City has earned well-deserved recognition for its charm and aesthetics, garnering the title of America's "Most Beautiful Small Town" by Rand McNally in 2013. Beyond its accolades, the city's allure lies in its unique blend of history, education, and natural beauty.
